

WHERE THE #THEDALE ARE WE?

TERMS AND CONDITIONS

1. By submitting an entry to this promotion the entrant is deemed to accept these Terms and Conditions.
2. Entry is open to all Australian residents.
3. Employees of the Promoter, its contractors and agents associated with this promotion and their immediate family, are not eligible to enter. For the purpose of this clause 'immediate family' means spouse, de-facto, child or step-child (whether natural or by adoption), parent, step-parent, grandparent, step-grandparent, uncle, aunt, niece, nephew, brother, sister, step-brother, step-sister or first cousin.
4. This promotion commences at 9.00am AWST Tuesday 1 September 2015 and closes at 5.00pm AWST on Saturday 5 September 2015 ("Promotional Period").
5. To enter, individuals must visit the City of Armadale Facebook page, find the daily promotion and guess all three locations each day during the promotional period, using the hashtag #TheDale. The first three people to guess all three locations in each daily competition post will win, as judged by the Facebook timestamp. This will run each day through the promotion period, with three winners on each of the five days (a total of up to 15 winners).
6. A maximum of one prize will be awarded to each winning entrant throughout the promotion period.
7. We reserve the right to remove/disqualify any comments that the City of Armadale deem to be inappropriate, obscene, offensive or defamatory. This is at the sole discretion of the City of Armadale.
8. This is a game of skill. The winners will be chosen based on whether they can accurately name the location of each of the three photos in a post on each of the five days during the promotion period, deemed by a panel of judges at Clarity Communications.
9. If more than one response occurs at the same time, a judgement will be made by the Promoter at its sole discretion as to who the chosen winner(s) will be.
10. Each winner will receive the prize of their choice of one of the images taken as part of this promotion. This will be signed by the photographer and framed.
11. The Promoter will announce each daily winner on Facebook within 12 hours. The winner will have 14 days to contact the City of Armadale to claim their prize.
12. The City of Armadale reserves the right to allow 30 days after the close of the competition period for the prize to be available for collection from the City of Armadale: 7 Orchard Ave, Armadale WA 6112.

If any part of the prize is unavailable, the Promoter, at its sole discretion, reserves the right to substitute the prize (or that part of the prize) with a prize to the equal value and/or specification, subject to any law or written directions from a regulatory authority.
